faculty Spotlight

DR. STEPHEN O. MORRELL, PH.D. BY ANDRES JARAMILLO

Q: Let's start with a little bit about your background. Where are you from, where and what did you study in college, and how did you end up at Barry University?

I am from Virginia. My mother's family came to Virginia from England in 1622 as indentured servants. Indentured servants were people who sold themselves into bondage (slavery) to others for terms of at least 7 years. My father's family immigrated to Florida from England in 1912. In college I studied economics. Indeed, I liked it so much that I have a B.S., M.A., and Ph.D. in economics. I attended undergraduate school at UVA and graduate school at Va. Tech.

I journeyed to Barry University through Barry's then President Sister Jean O' Laughlin. As an economist I had worked for the Federal Reserve System/Federal Reserve Bank of Atlanta, and then Southeast Banking Corporation in Miami. As Southeast's Chief Economist, through the Bank's Charitable Foundation, I first was introduced to Barry University and then the Andreas School of Business. I served on the ASBs Business Advisory Board. When the Miami Herald wrote an article about my leaving Southeast Bank, one of the first people to contact me was Sister Jeanne. Our conversations evolved to my becoming a professor at Barry University. This was about 30 years ago.

Q: What do you see as your role here at the university, in the honors program, and within other extracurricular programs?

I see my primary role at Barry as enhancing, extending, and supporting Barry's Mission. In particular, I try to bring keen interest, enthusiasm, commitment, and a drive for excellence to everything I do at Barry. Simply put, our students and the entire Barry community deserve the very best I can contribute.

In terms of the Honors Program, I view my role as twofold: first, as a member of the Honors Program Committee I work for and advocate initiatives -of all types – that will strengthen the Program. And second, as a frequent Honors Program Thesis Committee Chair, I direct and mentor students to complete theses that provide a valuable learning experience and also provide then a sense of accomplishment, achievement, and a building block for further growth and development.

Within other extracurricular programs, for the past 10 years the Barry University Student Managed Investment Fund (SMIF) has been my 'labor of love.' As the first Faculty Advisor in this Program I've been dedicated to SMIFs dual mandates of experiential and service learning. Owing to the sheer hard work, perseverance, tenacity, creativity, dedication, and leadership of many people from Barry Trustees, Advisory Board members, leaders in the business community, Barry's Administrations, Deans, Faculty and especially Barry students and alumni SMIF has grown and developed into a stellar program. I also need to mention that I have been for about the past ten years a strong advocate for informing the Barry Community of its rich Dominican Heritage.

BRIANNA LOPEZ'S ADVICE TO SENIORS BY REBECA MIRANDA

For this newsletter issue, I was asked to write an article on Brianna's graduation experience. Given I will be graduating in May, I decided to ask her questions on both the challenges she faced and her advice for seniors. Brianna graduated in May of 2022. Her major was English with a specialization in Professional Writing.

Brianna admitted to having dealt with stress while pursuing her career at Barry, and said that what helped her cope with said stress was taking a step back from her work. She expressed that writing her honors thesis caused her the most stress, and that stepping back every so often is what helped her avoid becoming overwhelmed. She described several ways of "taking a step back," some of which included going out with friends and taking a walk.

With regard to preparing for graduation, Brianna recommended that seniors stay on top of deadlines, and ensure they are prepared for what comes after that milestone. WHAT YOU SHOULD KNOW: SOC 394H BY ISABELLA TUSA



The Honors course, *Sociology- The World in America (SOC 394H), taught by Dr. L. Konczal*, is centralized around analyzing and understanding the relations of power and inequality from both a national and global perspective. From theories, industrialization, and colonialism, the topic I found most interesting that we discussed in the class so far is the current, racial, and ethnic stratification/immigration section. We discussed racial inequality, the mistreatment of groups, an example being the "one-drop rule," that categorizes individuals as being black. Inequality in mass incarceration, housing value, and education are all evident in America years ago, and even still today. An assignment I produced regarding racial stratification still evident in the criminal justice system analyzes, "Redesigning Racial Caste in America via Mass Incarceration" by Gilda Graff, "The new Jim Crow: mass incarceration in the age of colorblindness" by Michelle Alexander, and "The Help" a film directed by Tate Taylor.

ANALYSIS ON FILM: "THE HELP" DIRECTED BY TATE TAYLOR

As this was representing the 1960s in Jackson Mississippi, one of the prominent themes in the film was racism because of the Jim Crow laws in place. Many white people in the town talked about frequently, and the white women who employed the maids felt that black people were less than them, and verbally abused them often. There was a specific situation where a housewife was furious when a maid, ("the help" as they refer to them as), used her bathroom. This showed the viewer that people of color were depicted as being dirty, or inferior to white people. Another practice that showed during the film was the maids raising the housewives' children as their own, yet were still abused. The connection between the main character, a maid, and a little girl was like a mother and daughter. Another example in the film, referenced a black individual being killed by the KKK which was expressed to be normal. Social class is another main theme in the film, and there are many instances where this is expressed through what they wear, their homes, neighborhoods, and cars. In this film, colored people did not own cars, so they took public transportation and sat in the back. The last key theme in the film was uncovering the truth. As the film progressed there was one white female character who went by "Skeeter" that understood the harsh perspective for the 'help'. She was also raised by 'the help' and built a strong bond with her maid who unfortunately passed away. She was a driven writer that was inspired by the stories the other maids would tell her, and eventually she wrote a book. She anonymously, had it sold in bookstores and kept every maid's identity confidential as the public began to read it. The mistreatment was exposed, and it opened everyone's eyes while turning the page for many colored people in Jackson.

U.S. CRIMINAL JUSTICE SYSETM IS FLAWED

To depict a major issue, it would be racism. To highlight, conflict theorist Gilda Graff, considers mass incarceration as a form of convict leasing, a system in the south where southern states leased prisoners to do labor for free. The labor was also very dangerous with horrific conditions. Graff and Alexander both uncover discrimination through mass incarceration. Alexander presents a society today who promote colorblindness and use this to avoid using race as justification for discrimination, however, "Rather than rely on race, we use our criminal justice system to label people of color "criminals" (Alexander, 2010). This effect which produces the mass incarceration of colored people in prison, shows that the practices were never left behind. There are many variables that must be considered to reveal the unjust, unequal system America is supporting. Graff mentions the unfair labor market, community placement, war against drugs, unemployment, imprisonment, and stop-and-frisks. Drugs were a prominent way of putting, in specific, black males in jail. Stop-and-frisks were the most convenient way to show dominance over the black community and put many individuals in prison. Once charged with a drug-arrest, the "badge of inferiority" or being ineligible for any federal funds once discharged stays forever (Alexander, 2010). Graff and Alexander both expose the U.S criminal justice system for the wrongdoing and segregation that they put back into society.

AMBIGUITY AND FRAGMENTATION: MODERNIST APPROACHES TO RACE, GENDER, AND DESIRE BY VIRGINIA RIVAS. REBECKA MELLOR. ALYSSA DIAZ. **ANN-STACEY DUMORNAY. & JULENE URKIDI**

Modernism was not only a combination of magnificent creative forces which revolutionized artistic conventions. It also dramatically articulated what happened in the 1920s: Race and gender boundaries are explored. Masculinity is guestioned. A new woman emerges. The lack of influence the individuals have over their circumstances leads them to attempt impulsive decisions to increase freedom to live their lives. Feeling a silent regret over their lifestyles they are now in, which leads to disillusionment. SUMMARY OF SENIOR HONORS THESIS BY ANNA GALAKTIONOV

"The Relationship Between Musical Harmony and Emotions"

I would first like to acknowledge that being an Honors Program student at Barry University was such a blessing in my education! I've learned much invaluable information from all the Honors Program professors, which will definitely be of crucial use to me as I begin my career as a middle school band director in January! One of the highlights of being in the Honors Program for me was writing my thesis. I'll admit that the writing process was straining and difficult at times, but thankfully, with the help of my thesis advisor, Dr. Peter Brewer, and the other committee members, I made it! I'm now ready to defend my thesis on December 2nd. Prior research seems to show that humans universally, regardless of race, economic status, living conditions, or culture, sense emotions when listening to music. Moreover, studies have shown that harmony, which is the combination of notes played simultaneously to create the emotional context of the music, seems to be one of the musical elements that is most considered by listeners when identifying the emotions, a piece of music communicates. For example, when hearing music with predominately minor harmonies, listeners almost unanimously agree on feeling a dark emotion, such as sadness or melancholy, whereas when hearing music with predominately major harmonies, listeners, again unanimously, agree on feeling happy and light-hearted emotions.

Within my thesis, I compiled a meta-analysis of six different research studies to analyze the impact of harmony on the perception of emotions in isolation. I sought to determine whether harmony without the accompaniment of the other musical elements can still illicit emotional responses in listeners, and based on my meta-analysis, it seems to maintain this ability. This observation appears to suggest that the mathematical ratios between the notes within a certain harmony are sufficient for the human brain to perceive an emotion.

Furthermore, with my meta-analysis, I also strived to pinpoint whether the association of happy and bright emotions to consonant (balanced) harmonies and of sad and distressed emotions to dissonant (unbalanced) harmonies is biologically innate or enculturated and learned. I sought to ascertain whether the emotional responses to consonant and dissonant harmonies are driven by nature or by nurture. The results of my meta-analysis, which spanned animal, infant, and cross-cultural studies, seemed to suggest that humans sense emotions from harmony due to a biological innateness, which means that they are born with the capacity to relate positive emotions to consonant harmonies and negative emotions to dissonant harmonies. If this phenomenon is fundamentally biological, humans then unanimously identify emotions in harmony due to the acoustics their ears are accustomed to and the neurological workings of the brain.

The biological innateness of the relationship between harmony and emotions has many benefits for socialemotional learning in children and clinical music therapy for patients. If educators and music therapists would be taught the impacts of harmony on the perception of emotions, they could then more precisely and accurately tailor the music they play in the classroom or hospital to the emotional responses they are seeking from the students or patients. In summation, I hope I did not lose anyone with the technicality of my thesis, but I anticipate it will ultimately bring many benefits not only into the fields of education and clinical music therapy, but into many other fields as well. In essence, when choosing your music, go with what your ear and brain tells you! According to my meta-analysis, you are most likely biologically attuned to choose the music that would suit your mood anyway!





SUMMARY OF SENIOR HONORS THESIS BY HEAVEN LASTER-TORRES





"Letting the Science Speak: What the United States Learned from COVID-19"

This study aims to explore how COVID-19 impacted the United States from 2020 to 2022, both positively and negatively, and to suggest plans of action scientists and government officials could take to ensure a better pandemic response in the future. I chose this topic because I plan on attending a master's program in public health and immunology. After the COVID-19 pandemic, I want to

be a part of the community that helps prevent and monitor diseases worldwide. Therefore, I based my thesis on this topic. For this thesis, I did a meta-analysis of multiple studies from The World Health Organization, the Centers for Disease Control and Prevention, and other reliable data sources.

Based on research, the lack of consistent national mandates resulted in people's disinterest in the pandemic, even during high infection rates. As a result, in many states, the pandemic has had devastating and long-lasting effects on the condition of their hospitals, morgues, senior homes, schools, and other businesses. In 2021 and 2022, the COVID-19 vaccine and mandates caused the division in the United States to worsen. Many people listened

to politicians rather than scientists, which uncovered a deep mistrust people have for the science community in the United States that needs to be addressed. This mistrust illuminated a lack of union and cohesiveness within the science community, which played a part in politics' ability to invade the pandemic response. I theorized that implementing aspects from other countries' successful pandemic responses, incorporating pandemic prevention in academic curriculum, and better funding and protection for public health institutions will prevent poor

pandemic responses in the future.



SUMMARY OF SENIOR HONORS THESIS BY ANDRES JARAMILLO

"Assessing the Risk-Adjusted Returns of ESG Security Investments"

My thesis studies the performance of Environmental, Social, and Governance (ESG) focused open-end and exchange-traded-funds compared to as comparable funds as possible excluding the ESG influence. I wanted to understand if the ESG element in funds added any value to investors and institutions or simply served as a marketing tool for product managers to entice investors geared towards "responsible/sustainable" investments.

After this research idea arose, I looked at MorningStar's database of all listed funds and added filters to finalize a list of ESG securities with identical investment styles: Large Capitalization operating in the US. I also chose two benchmarks to compare the returns from the selected funds with to understand if there is a significant enough difference between both groups' returns. As of now, the findings have not been conclusive enough, but I have plans of broadening the sample size and style of funds to try and reach a definitive conclusion. Other factors that may influence the returns of the funds that should be further explored include the equity selection of the fund managers, the sector/industry of the equity composition, as well as the nature of the funds whether actively or passively managed.

Since I am a co-managing director of the Student Managed Investment Fund (SMIF) at Barry University, responsible for co-managing the endowment fund of the University for financial aid purposes, I plan on incorporating my findings into the approach that we take in SMIF. Some of the guidelines that we follow may be adjusted or updated with my findings and this thesis has opened my eyes to some significant changes that can come in the industry.
